APPLICATION INSTRUCTIONS

Submit the attached group reservation form and insurance verification at least 3 weeks in advance of your proposed visit.

A certificate of insurance is required for group visits. The State of California must be named as “Additional Insured” on a policy of liability insurance that will cover the period of the permit in an amount not less than the following: Combined single limit (CSL) \$1,000,000 per occurrence. The policy must contain the following special endorsement:

State of California, its officers, employees, and servants are included as additional insured but only insofar as operations under this contract or permit are concerned.

The insurer will not cancel or reduce the insured's coverage during the period that this permit is in effect or without 30 days prior written notice, whichever is shorter, to the State.

Permit and facility use fees may be paid with the application or after confirmation of an approved date. Current fees are \$25. Group permits will be limited due to the Reserve's sensitivity to natural resource protection and limited carry capacity. Limited grants are available to cover the \$25 fee, but no parking passes will be issued.

Applications processed in the order received. Approved groups will receive parking pass(es) for 1 van or 3 cars at the entrance kiosk. No photocopied passes will be accepted. Additional vehicles must pay day use parking fees. Parking space availability is not guaranteed.

INFORMATION FOR ALL GROUPS

We hope you're looking forward to visiting Torrey Pines State Natural Reserve. Torrey Pines is one of only 14 Natural Reserves among California's 278 State Parks. A special place deserves special consideration. Our primary mission is to protect the animals and rare plants found here; humans are guests in nature's home.

Please **stay on the marked, wide trails**. Cutting across switchbacks and going into closed areas causes erosion and damages native plants. Split up into smaller groups of 12 or fewer while hiking to make the experience more enjoyable for yourselves, our other visitors, and the animals who live here.

To keep our animals wild and the Reserve trash-free, there is **no food and no smoking** in the upper Reserve; all snacks and lunch must be eaten at the Beach level. There are picnic tables available next to the Beach parking lot. Please leave lunches or snacks in backpacks until you reach the beach level. Do not feed the animals.

Everything in the Reserve is protected; **do not pick or collect anything**. Pinecones and flowers must be left to produce seed to grow new plants and as food for animals. **No dogs** allowed (except *working* service animals).

The **Visitor Center Museum** offers exhibits on the natural and cultural history and is staffed by knowledgeable docents who can answer many questions about the area and trails. Because the Museum is small, please bring no more than 20 people in at once.

If you plan a beach walk, please **check the tide table** first. During high tides, there may not be enough room to walk safely between the cliffs and the ocean. Always keep away from the bottom of the cliffs: rock slides can occur at any time.

Restrooms are available at the Beach level entrance and in the west parking lot at the top level, across the street from the Visitor Center. Water fountains are available at the Visitor Center, the restrooms, and on the Guy Fleming Trail.

Drive carefully on our road which is popular with cyclists. Observe the **15 mph speed limit**. Walk or run on the dirt shoulders of the road, not on the pavement.
